Subject :Halts to some passing trains at Khed

## Respected sir,

We have been following up with Konkan Railway for the last 3 years to provide a halt to some mail/express trains at Khed to handle increasing rush. Khed railway station over Ratnagiri Region of Konkan Railway serves 3 talukas viz. Khed, Dapoli and Mandangad from Ratnagiri district and some parts of Poldpur and Mahad taluka from Raigad district. Number of passengers originating their journey from Khed is close to 2000 per day, even during off peak season. This mandates at least 20 halting trains per day.

Hence, we would request to provide an additional halt to following trains at Khed:

- 1. 12051 / 12052 Mumbai CSMT ↔ Madgaon Jan Shatabdi Express (Daily)
- 2. 12201 / 12202 Lokmanya Tilak Terminus ↔ Kochuveli Garib Rath Express (Bi-Weekly)
- 3. 22115 / 22116 Lokmanya Tilak Terminus ↔ Karmali Superfast Express (Weekly)
- 4. 20931 / 20932 Indore ↔ Kochuveli Superfast Express (Weekly)
